Dinah Misner will present preclinical strategies to assess new chemical entities (NCEs) for cardiovascular liabilities early in the development process, with an emphasis on detection of QT prolongation and arrhythmias. Topics to be discussed include an overview of the current regulatory guidelines around pre-clinical cardiovascular assessment, discussion of state-of-the-art technologies for both *in vitro* and *in vivo* testing, and development of customized strategies to de-risk cardiovascular liabilities of NCEs. Additionally, specific examples will be provided where these new technologies have benefited projects to identify liabilities early, enabling selection of the "best" NCE moving forward.

GETA's Fall meeting was held on November 1, 2007 at Hs Lordship's Restaurant in Berkeley.

Mike Connor, Ph.D., Executive Director at the San Francisco Estuary Institute (SFEI) was the speaker.

Dr. Connor presented the efforts by the Regional Monitoring Program (RMP) for Water Quality in the San Francisco Estuary, which is administered by the San Francisco Estuary Institute.

Dr. Connor talked about studies that the SFEI conducted in emerging contaminants in the bay area in three separate studies: a study to determine concentrations of pharmaceutical compounds in waters of the estuary and in influent and effluent from two wastewater treatment facilities; a collaborative study with the Marine Mammal Center to determine the level of emerging contaminants in seals as part of a larger study to track the health of harbor seals; and lastly a study evaluating contaminants and hormone concentrations in fish from the San Francisco Bay. GETA DUES NOW DUE IN JANUARY

As many of you have discovered, GETA is in the process of converting our term of memberships to a calendar year basis.
